# 1 INTRODUCTION

The Lufthansa Group Airlines, Austrian Airlines (OS), Lufthansa (LH), SWISS (LX) Brussels Airlines (SN) and Air Dolomiti (EN) apply a Distribution Cost Charge (DCC) for tickets sold through GDS, e.g., Amadeus, Sabre, Travelport, etc. (EDIFACT).

In addition, a DCC applies for tickets sold through GDS NDC aggregators in the NDC Public Model.

These tickets are subject to the DCC in all markets. See [chapter 5](#) below for exceptions.

The Lufthansa Group airlines own sales bookings as well as NDC aggregator bookings under the Bilateral Model are not subject to the DCC.

The DCC rules are part of the filing and are processed automatically. Travel Agencies are requested to comply with the LHG carrier validation rules based on IATA Resolution 852 and mentioned in the Lufthansa Group Booking and Ticketing Policy.

## 2 DEFINITIONS

### **EDIFACT**

EDIFACT stands for 'Electronic Data Interchange for Administration, Commerce and Transport' established in the 1980s.

EDIFACT is a widely adopted standard for electronic communication and exchange of structured data related to airline reservations, flight schedules, ticketing, passenger information, and other administrative and operational functions.

It enables data exchange between airlines, travel agents, and other industry stakeholders, but has reached its limitation.

### **NDC**

NDC stands for New Distribution Capability and describes a pioneering data standard.

NDC is based on XML-based data transmission standard launched by the International Air Transport Association (IATA), that is driving standardization of the digital language throughout the industry.

NDC offers new opportunities in distribution and provides more comprehensive and personalized offers, while also improving the efficiency and flexibility of distribution channels.

### **LHG NDC Public Model**

Available through GDS NDC aggregators only and provides access to the **NDC Base Offer**, with a DCC in the form of OB-T.

### **LHG NDC Bilateral Model**

Provides access to the **NDC Smart Offer** of LHG with no DCC.

### 3 FEE LEVELS AND RULES (EDIFACT)

The **DCC is defined as a fixed amount per ticket**, does not vary by region or fare and is collected as **YR tax**.

DCC applies to all LHG tickets (OS, LH, LX, EN, SN) issued worldwide by a Travel Agency / Distribution Partner using a GDS.

The DCC amount corresponds to:

- EUR 19.00 for Amadeus (1A)
- EUR 22.50 for Sabre (1S/1B)
- EUR 23.00 for Travelport (1G/1P/1V),
- CNY 120.00 for Travelsky (1E) (POC CN with NDC go-live)
- JPY 3.500.00 for Infini (1F)

For international markets, the DCC is filed in CAD, GBP, JPY, IDR, and USD as shown in the table below:

Currency conversions are done as per standard conversion rules. In countries using USD as currency (e.g., MX, PA, BZ), the fixed USD amount is converted to the local currency like other taxes/fees/surcharges.

Identical to the standard YQ processing, the fixed amounts in other currencies than EUR only apply on a point of origin/point of commencement basis. The above rates are subject to regular revision.

### 3 FEE LEVELS AND RULES (EDIFACT)

#### Examples:

- Ticket issued in the US for travel originating in the US:
  - USD 22.00 for Amadeus (1A),
  - USD 26.00 for Sabre (1S/1B)
  - USD 27.00 for Travelport (1G/1P/1V)
  
- Ticket issued in the US for travel originating in DE:
  - EUR 19.00 for Amadeus (1A)
  - EUR 22.50 for Sabre (1S/1B)
  - EUR 23.00 for Travelport (1G/1P/1V)

Above EUR amounts are converted by the GDS rate of exchange (BSR) applicable at time of ticket issuance to USD (=payment currency).

## 3.1 Collection of DCC (EDIFACT)

- DCC is collected for all tickets issued by a Travel Agency/Distribution Partner via any GDS (e.g., Amadeus, Sabre, Travelport, Infini, Travelsky) on the ticket stock of an LHG airline (OS, LH, LX, EN, SN)
- DCC is charged per ticket (including conjunction tickets) for all itineraries (domestic and international). It applies to all RBDs, all compartments and all fare types (published as well as unpublished).
- Applicable on original ticket (first issues), no DCC is collected for reissues.
- Applicable to tickets only, not to EMDs or other documents.
- PEP and AD/DG, etc. tickets issued by Travel Agencies via NDC Public Model are subject to DCC.
- CBBG (additional seat for cabin baggage) two tickets need to be issued as per standard policy. DCC must be collected for each ticket.
- EXST: One ticket needs to be issued as per standard policy. DCC must be collected once.

### Discount

No discount on DCC amounts applies.

### Refundability:

The DCC is non-refundable except in involuntary scenarios for completely unused tickets.

## 4 FEE LEVELS AND RULES (NDC PUBLIC MODEL)

The **DCC is defined as a fixed amount per ticket**, does not vary by region or fare and is collected as **carrier ticketing fee (OB-T)**.

DCC applies to all LHG tickets (OS, LH, LX, EN, SN) including 4Y flights, issued worldwide by a Travel Agency / Distribution Partner using a GDS NDC aggregator.

The DCC amount corresponds to:

**EUR 8.00** for

- Amadeus (1A)
- Sabre (1S/1B)
- Travelport (1G/1P/1V).

and CNY 65.00 for Travelsky (1E)

Amounts above are applicable once the NDC Public Model is available for the specific GDS NDC aggregator and market.

For international markets, the DCC is filed in CAD, GBP, JPY, IDR, and USD as shown in the table below:

## 4 FEE LEVELS AND RULES (NDC PUBLIC MODEL)

### Currency conversions

Standard conversion rules apply, e.g., in countries using USD as currency (e.g., MX, PA, BZ), the fixed USD amount is converted to the local currency like other taxes/fees/surcharges.

The above rates are subject to regular revision and may vary per GDS NDC aggregator.

**Note:** The fixed amounts in other currencies than EUR only apply on a point of origin/point of commencement basis.

### Example:

- Ticket issued in the US for travel originating in the US:  
DCC amount is USD 9.50 for all GDS NDC aggregators.
- Ticket issued in the US for travel originating in DE:  
DCC amount is EUR 8.00 for all GDS NDC aggregators.

The base fare is quoted in EUR and converted by the GDS rate of exchange (BSR) applicable at time of ticket issuance to USD (= payment currency).

## 4.1 Collection of DCC (NDC Public Model)

- DCC is collected for all tickets issued by a Travel Agency/Distribution Partner via any GDS (e.g., Amadeus, Sabre, Travelport, Infini, Travelsky) on the ticket stock of an LHG airline (OS, LH, LX, EN, SN)
- DCC is charged per ticket (including conjunction tickets) for all itineraries (domestic and international). It applies to all RBDs, all compartments and all fare types (published as well as unpublished).
- Applicable on original ticket (first issues), no DCC is collected for reissues.
- Applicable to tickets only, not to EMDs or other documents.
- PEP and AD/DG, etc. tickets issued by Travel Agencies via NDC Public Model are subject to DCC.
- CBBG (additional seat for cabin baggage) two tickets need to be issued as per standard policy. DCC must be collected for each ticket.
- EXST: One ticket needs to be issued as per standard policy. DCC must be collected once.

### Discount

No discount on DCC amounts applies.

### Refundability:

The DCC is non-refundable except in involuntary scenarios for completely unused tickets.

# 5 EXCEPTIONS

Generally, the DCC is charged on all fares and booking classes.

## **Country specific exceptions:**

Currently all tickets with the following point of origin/point of commencement are exempted from the DCC:

- Hong Kong
- Iran
- Libya
- Yemen

## **5.1. Exceptions for EDIFACT**

No DCC is charged on following tickets (worldwide):

- INF tickets.
- Pure EW itineraries on LH documents – in case of mixed travel itineraries, e.g., EW with OS/LH/LX/SN/EN, the DCC is applicable irrelevant of ticket stock.
- LH only: Rail&Fly tickets (in Germany) and Lufthansa Airport Bus tickets if issued in a separate ticket.

## **5.2. Exceptions for NDC Public Model**

No DCC is charged on INF tickets (worldwide).

## 6 GROUP BOOKINGS

### **EDIFACT**

The DCC is applicable for group bookings.

The DCC is applicable for group bookings and is provided in the currency that is valid for the Point of Commencement. At time of ticketing the DCC needs to be converted into the local currency of the agent using the exchange rate valid at time of ticketing (=BSR).

In case of a change of the DCC amount, the new amount will apply for group bookings if the group request date is on/after the announced date of the change.

### **NDC Public Model**

Group bookings are currently not available in NDC Public Model.

## 7 REFUNDS

In general, the DCC is non-refundable unless legally required.

**Exception:** The DCC may only be refunded in case of involuntary refunds of completely unused tickets. For partially used tickets the DCC is non-refundable.

**Note:** All DCC refunds must be processed to the original form of payment.

### **EDIFACT:**

Travel Agencies using semi-automated refund tools with predefined settings must manually remove the DCC YR tax from the refund mask when applying for refund on voluntary basis or for refund of partially used tickets on involuntary basis.

### **NDC Public Model:**

In an involuntary scenario with a completely unused ticket, the OB-T fee must be refunded manually via BSP Refund Application or known local processes.

## 8 SALES AUDIT

The DCC is subject to sales audit – i.e., an ADM will be issued for any missing DCC.

Refunded DCCs are also checked during standard fare audit and will result in an ADM in case of incorrect refund, e.g., if a DCC was refunded on voluntary basis.
