## Eligibility / Scope

Ticket Issue Date	On/before <b>14APR26</b>	
Ticketed Flights and geographical Scope	<ul style="list-style-type: none"> <li>LH operated flights, including Lufthansa CityLine (CL)</li> </ul> (Please note: this TWP does not include flights operated by other LHG carriers such as OS/SN/LX/4Y/VL/EN)	<b>To/from/within Germany</b>
Ticketed Dates of Travel	<b>On/after 13APR26 and on/before 19APR26</b>	

## Voluntary Rebooking

Rebooking Rules	One rebooking free of charge on original origin & destination Rebooking fee and fare difference waived. Tax balance may be ignored.
New Date of Travel	On/after <b>11APR26</b> and on/before <b>24APR26</b>
RBD/Booking class	<ul style="list-style-type: none"> <li><b>LHG-operated flights:</b> Any RBD in originally ticketed compartment</li> <li><b>UA/AC/NH/OAL-operated flights:</b> Per original fare rule</li> </ul>
Change of origin/destination	Not permitted
Permitted flights/carrier usage	Per original fare rule(s)
Other fare rules/conditions	Per original fare rule(s)

**Voluntary Refund**

Refund Rules	<b>Refund permitted before departure</b> (travel date to/from Germany). Fare rule refund penalties and restrictions waived.
Refund transaction date	<ul style="list-style-type: none"> <li>Last date of refund transaction: <b>on 19APR26 or before ticketed travel date, whichever is earlier</b></li> </ul>
Unused Tickets	Full refund permitted. OPC and DCC remain non-refundable.
Ancillaries	Refund of unused ancillaries associated with refunded coupons is permitted.

**Handling instructions for travel agents:**

- Travel agents may not use automated refund tools (e.g. Amadeus Ticket Changer, NDC TrueReshop, Travelport Rapid Reprice, etc.). Manual processes apply.
- Waiver** from your Lufthansa Group Agency Support **not required** provided TWP conditions are fulfilled and refund mask entry made correctly.
- You can do the **refund for unused tickets** in accordance with this Ticketing Waiver Policy (TWP 2608) and entry of the waiver code without having to request a waiver from your Lufthansa Group Agency Support.
- Partially used tickets:** Please raise refund application via BSP or other local processes (in non-BSP markets).
- All transactions are subject to audit. Non-compliance with TWP rules will result in an Agent Debit Memo (ADM).

**Endorsement Box:**

Travel Agents must enter: **“TWP2608”** followed by the FE box original entries.  
 Example: TWP2608 FARE RESTRICTIONS MAY APPLY

**Refund mask:**

Mandatory entry of **“TWP2608”** in waiver field / airline authority box of the refund mask.

- Amadeus: TRFU/WA TWP2608
- Farelogix-SPRK: Enter “TWP2608” in the Refund window / Waiver code box
- Galileo/Travelport: Start direct refund via TRNE entry. Enter “TWP2608” in the waiver box (A/L authority).
- Sabre: After direct refund “WFR” entry, enter “TWP2608” in the waiver box
- Infini: Enter “TWP2608” under Refunds – Reason Code
